3. This unit is composed, with the exception of less than one per cent, of men born in the Hawaiian Islands. Hence, something Hawaiian in design is felt to be more appropriate. With the exception of one per cent every man in the unit was in service at the time of the December 7th attack, about 62% on the island of Oahu, about 38% on the outlying islands. These men are all entitled to the service bar with bronze star.

4. It is felt that of all units organized at that time none is more entitled to the motto "Remember Pearl Harbor" than this one; other units on duty in the islands at the time already had their coats of arms.

5. Coats of arms of the 298th and 299th Infantry Regiments are pinned below. It is felt that a design based on and similar to No. 32 of the inclosed entries is more in keeping with the origin and history of this unit.





HEADQUARTERS 100TH INFANTRY BATTALION (SEP), Camp McCoy, Wisconsin, 14 Dec 1942. To: Office Quartermaster General, Heraldic Section, Washington, D. C.

1. No previous knowledge of a proposed design of a Coat of Arms for this battalion has reached the undersigned. However, in accordance with a Memorandum to all units of the battalion under date of 29 September, 1942, copy of which is inclosed, about forty-five designs were submitted by enlisted men of the unit. As stated in the Memo these designs were intended for organizational marking. Inasmuch as authority for said marking has since been withdrawn, no further action has been taken. The best designs are inclosed.

2. This unit is composed almost entirely (approximately 95%) of former members of the 298th and 299th Infantry Regiments. It is felt that its history is the history of the two regiments named and that any honors they might be entitled to also pertain to this unit. Files in your headquarters are more complete in this respect than any information that is available here.

SPQRD 424 - 100th Infantry Battalion 4th Ind. War Department, O.Q.M.G., Washington, D. C., December 7, 1942. To: Commanding Officer, 100th Infantry Battalion, Camp McCoy, Wisconsin.

1. In connection with the outline history of the 100th Infantry Battalion, as contained in preceding 2nd Ind., it is advised that a coat of arms may be authorized under the provisions of paragraph 5, AR 260-10, November 20, 1931.

2. In accordance with the policy of the War Department, this office is glad to render every assistance in the development of a coat of arms, and to this end has prepared Inclosure #1, which is submitted for consideration and which is described:

SHIELD: Azure, a bayonet in pale argent, inflamed proper, between two annulets of the second.

CREST: None.

MOTTO: Be of good courage.

DESCRIPTION

The blue is for the Infantry, the functions of the Battalion being allegorically illustrated by the ancient weapon of that arm, inflamed for courage and zeal. The annulet represents the ring hung from a cross beam at medieval tournaments, which had to be carried off on the tip of a participant's lance as he rode by at full tilt. The numerical designation is attractively illustrated by the sword (1) and the two annulets (00). The suggested motto, "Be of good courage", is an admonition to the personnel to retain their courage under all circumstances.

3. If a motto other than the one suggested is desired by the organization, it is recommended that several mottoes be submitted in the order of preference, together with their translations, if in a foreign language, so that they may be checked against those already approved or reserved for other organizations. The first acceptable motto that is distinctive will be reserved for the Battalion.

4. If distinctive insignia are desired for wear upon the uniform under the authority of paragraph 51, AR 600-40, August 28, 1941, application for approval should specify the composition desired, i.e., the shield or shield and motto of the coat of arms. The coat of arms when appearing on the organizational standard should be on a shield of the shape as shown by figure 3 on page 3 of the inclosed
